- 2. Proposals for nomination of members in varied Cantt Boards, as received from PCBs/CEOs were forwarded to GoC-in-C for recommendation.
- HQ CC vide letter No. 260506/Varied Bd/Q3L2 dated 22-03-2021 (copy enclosed) has sought certain additional information and documents. Therefore, you are directed to forward the following information:
 - a) The recommended panel of three names duly endorsed by of PCB & CEO.
 - b) Following data with reference to each individual in the panel of names;
 - i) Basic particulars and details of individual including spouse and children.
 - ii) Police verification and details of any ongoing / pending criminal / civil cases.
 - iii) In event of an individual being in occupation of OGB, then his status with reference to HOR / occupier / on rent / others (should be specified).
 - iv) In context of para 3 (b) (iii) above, details with respect to any breach of terms of OGB, even if he / she is not the HOR.
 - v) Certificate from DEO & CEO with reference to their respective domains that no unauthorised construction activity or illegal activity, has been carried by the recommended individuals (CEO must obtain requisite certificate from concerned DEO at their end and enclose the same with CEOs certificate).
 - vi) Any pending rent & allied charges / licence fee, which are due to be paid by the recommended individuals to the Cantonment Board.
 - vii) Priority of candidates as per PCB / CEO.

- 4. You are directed to forward information and documents as as mentioned above to this Dte by 26-03-2021, without fail. While sending the information and recommendation the PCBs and CEOs must keep in view that a person of good reputation, law abiding and having sound knowledge of administrative command and control with reference to Cantonment Board functioning would help the PCB and CEO in overall administration of the Cantt Board Matter while maintaining a fine balance of public representation.
- 5. It is observed that Presidents of Agra & Fatehgarh Cantt Boards had directly forwarded the proposals to HQ CC. These are requested to forward the information and documents to this Dte, so that the same be scrutinized and recommendations of the PD DE may be made to enable GoC-in-C in taking a decision on the subject.
