To consider the lowest tender and estimates for "Boring of Deep Tubewell by D.C. Rig in Cattle Dairy, Atal Road near OHT No. 2, compound, Kasaibara, Lucknow Cantt".

The P.Dte DE CC office vide their letter referred above has accorded sanction for the work 'Boring of Deep Tubewell in Cattle Dairy, Atal Road in replacement of Tubewell No. 7 in OHT No. 2 compound, Lucknow Cantt' under allotment of Share of Revenue (15<sup>th</sup> CFC recommendation).

Accordingly, E-tenders were invited for the first time through Government e-procurement Portal bearing Tender Ref No. LCB/5/E/M/Boring/Deep Tubewell/2021, published in daily newspapers namely Rashtriya Sahara (Hindi) and The Indian Express (English) on 02.03.2021. In response to the tender notice, four bids were recieved on 24.03.2021 and after the evaluation of the technical bids; it is found that three bidders qualifies in the technical evaluation. Accordingly their financial bids were opened on 07.04.2021. The details of the same are as under:

# Office Note:

The lowest tender rate of Rs 48,72,000/- only for the work of "Boring of Deep Tubewell by DC Rig in Cattle Dairy, Atal Road near OHT No. 2, compound, Kasaibara, Lucknow Cantt" is quoted by M/s C.I.T. Drillers & Developers. The lowest rates quoted for the subject work by M/s C.I.T. Drillers & Developers are 0.58% more than the estimated cost of the work and seems reasonable as per prevailing market rates. Further, it is pertinent to apprise the Board that the Board vide its CBR No. 11 dated 24.02.2021 approved the work of one Reboring of Deep Tubewell by DC Rig in OHT No. 2 Compound, Kasaibara, Lucknow Cantt for Rs. 48,89,000/- which is currently under progress.

An estimate of Rs 48,42,000/- is also prepared for the work of 'Boring of Deep Tubewell by D.C. Rig in Cattle Dairy, Atal Road near OHT No. 2, compound, Kasaibara, Lucknow Cantt' which is based on the lowest rates as mentioned above and the bid received seems reasonable in view of the estimate prepared.

The expenditure to be incurred in the execution of the said work will be booked under allotment of share of revenue derived by State Govt. to Lucknow Cantonment Board (15<sup>th</sup> Finance Commission Recommendation) i.e. 2<sup>nd</sup> installment of Tied Grant under allotment of share of revenue for the year 2020-21 which has been extended upto 31.07.2021 vide Directorate of Local Bodies letter No. 8/1324/15<sup>th</sup> Vi.Aa./2020-21 dated 23.04.2021.

The tenders were invited through Government e-procurement Portal bearing Tender Ref No. LCB5/E/M/Electrical item/2021, published in daily newspapers namely Amar Ujala (Hindi) and The Indian Express (English) on 15.03.2021. In response to the tender notice, three technical bids were received on 05.04.2021 and were opened on 07.04.2021. After the evaluation of technical bids, all three technical bids were found valid. The lowest tender rates for the work of "Supply and installation of electrical items at various locations in Cantt area Lucknow" are quoted by M/s Ram Singh Agarwal. It is submitted that the rates quoted by M/s Ram Singh Agarwal. for the subject work are found reasonable as the rates are approximately at par with the items wise rates quoted for the same work previously which was approved by the Board vide its CBR No. 14 dated 30.07.2019

Considered and approved the lowest bid quoted by M/s Ram Singh Agarwal. Necessary agreement be executed with the firm.

# 7. E-TENDER/ BID FOR GRANT OF ADVERTISEMENT RIGHTS ON TREE GUARDS/ PLANT STANDS, ELECTRIC/ STREET LIGHT POLES, UNI-POLES, BUS/ RAIN SHELTERS AND LED WALL SCREEN IN CANTT AREA LUCKNOW FOR THE PERIOD OF THREE YEARS

To consider the lowest tender for "Grant of advertisement rights on tree guards/ plant stands, electric/ street light poles, uni-poles, bus/ rain shelters and LED wall screen in Cantt area Lucknow for the period of three years".

Tenders were invited for the **first time** through Government e-procurement Portal bearing Tender Ref No. LCB5/E/M/Advertising Rights/2020, published in daily news papers namely The Pioneer (Hindi) and The Indian Express (English) on 23.11.2020. In response to the tender notice, no technical bid was received on 14.12.2020 and the tender was cancelled due to non submission of minimum bids. The tenders were re-invited for the **second time** through

Government e-procurement Portal bearing Tender Ref No. LCB5/E/M/Advertising Rights/2021, published in daily news papers namely Hindustan (Hindi) and The Pioneer (English) on 08.01.2021. In response to the tender notice, no technical bid was received on 29.01.2021 and the tender was cancelled due to non submission of minimum bids. The tenders were re-invited for the **third time** through Government e-procurement Portal bearing Tender Ref No. LCB5/E/M/Advertising Rights/2021, published in daily news papers namely Rashtriya Sahara (Hindi) and The Pioneer (English) on 12.02.2021. In response to the tender notice, only one technical bid was received on 27.02.2021 and the tender was cancelled due to non submission of minimum bids. The tenders were re-invited for the **fourth time** through Government e-procurement Portal bearing Tender Ref No. LCB5/E/M/Advertising Rights/2021 published in daily news papers Amar Ujala (Hindi) and The Indian Express (English) on 20.03.2021.

Since due to the current pandemic situation there is a fall in the advertisement business and any firm has not participated for the first three times in the tender. So as to ensure more participation from the advertising firms in the fourth call the tenders were invited after calculating the estimated revenue as per the class C category and also relaxing the qualifications conditions. It is also allowed to the firms to bid either for Tree Guards/ Plant Stands or for Unipoles, Bus Shelters, LED Wall Screen & Street light Poles. In response to the tender notice, three technical bids were received on 10.04.2021 and after the evaluation of the technical bids, only two technical bids were found valid and both the firms have quote there rates only for serial No. 2 of the BoQ i.e. for Unipoles, Bus Shelters, LED Wall Screen & Street light Poles only. Accordingly the financial bids of the eligible bidders were opened. The details of the bid are as under:

### Office Note:

The highest bid of Rs. 3546562.50 for "Grant of advertisement rights on Unipoles, Bus Shelters, LED Wall Screen & Street light Poles in Cantt area Lucknow for the period of three years" is quoted by M/s Vital Assets Consultants Pvt. Ltd. The highest bid quoted by M/s Vital Assets Consultants Pvt. Ltd. is 0.82% higher than the estimate of Rs. 3517855.83 for three years prepared for the work based on Uttar Pradesh extraordinary Gazette and is reasonable as per the office report of JE (E/M) dated 30.05.2021.

The tender and all relevant documents are placed on the table.

# 7. RESOLUTION

Considered and approved the highest bid quoted by M/s Vital Assets Consultants Pvt Ltd. Necessary agreement be executed with the firm.

Further, the CEO apprised the Board that since the quoted rates are for grant of advertisement rights on Unipoles, Street Light Poles, LED Wall Screen and Bus Shelters only. Separate tender may be invited for grant of advertisement rights on Tree Guards & Plant Stands. Meanwhile, advertisement rights on Tree Guards & Plant Stands may be given to the interested parties on the prevailing rates till the finalization of the fresh tender.

Board agreed with the same.

# 8. <u>AUGMENTATION OF INFRASTRUCTURE FOR PROVIDING COVID CARE FACILITY AT</u> CGH LUCKNOW CANTT

Reference Special CBR No. 1 dated 19.04.2021, CBR No. 18 dated 16.03.2021, representation dated 31.03.2021 & 31.05.2021 of Buddheshwar Vimla Hospital, Lucknow and meeting chaired by the Defence Secretary, MoD, Gol dated 19.05.2021.

To consider the matter for augmentation of infrastructure for Maternity & Pediatric Covid Care / Isolation Facility at Cantt General Hospital, Lucknow Cantt on PPP Model in wake of possible third wave of Covid-19.

# **Office Note:**

As the Board is well aware of impact of second wave of Covid-19 not only in Lucknow but to whole India and due to lack of infrastructure / equipment's such as Oxygen, medicine and dedicated hospital / centres, we have lost thousands of lives.

Earlier, the Board vide CBR No. 1 dated 19.04.2021 approved opening of 40 Beded Covid Isolation Centre (Level-1) on PPP Mode at RA Bazar School and also approved required infrastructure. Later, on keeping in view the requirement, the same was upgraded from 40 to 50 bed without investing addition amount for the same. The said Centre proved its utility and resulted in saving lives of hundreds of patients and also got appreciation of general public and attention of media.

Now, in order to effectively fight with possible third wave of Covid-19 there is need of a dedicated Maternity & Pediatric Covid Care Facility / Centre to serve people of Cantonment area as guided by Hon'ble Defence Secretary. Although, we are successfully running a 40 bedded (upgraded to 50 Beds) Covid Isolation Center at R.A. Bazar in association with a third party namely Buddheshwar Vimla Hospital on PPP Mode, however, expansion of said facility at R.A. Bazar is limited. Therefore, it is felt that existing isolation center is required to be shifted at Cantonment General Hospital to provide comprehensive medical facility interalia including General Ward for all Category of patients and to provide separate maternity and pediatric ward having OT & USG for Covid and non-Covid patients including evening OPD. In this regard, the Board vide its CBR No. 18 dated 16.03.2021 has already approved EOI / Proposal of Buddheshwar Vimla Hospital for running OT and Ultrasound Facility on revenue sharing mode.

Further, our PPP Partner who is running Covid Isolation Centre at RA Bazar School vide letter dated 31.05.2021 informed that due to lack of patient at existing Covid Isolation Centre they are unable to run the Covid Isolation Centre and requested this Board to consider their another proposal dated 31.05.2021 in continuation to their earlier proposal which has been approved vide CBR No. 18 dated 16.03.2021 related to running of OT and Ultrasound Facility at CGH Lucknow. In the instant proposal dated 31.05.2021 Buddheshwar Vimla Hospital offered mainly the following services:

- 1. A 6 bedded maternity ward including 3 NICU and PICU bed will be operated by them.
- 2. A separate maternity ward will be opened by them for treatment of Covid Positive Pregnant Women.
  - A separate 5 bedded pediatric ward equipped with PICU will also be operated by them for Covid positive children.
- 3. Evening OPD will also be operated by them for the patient of gynecology and pediatric at CGHS Sadar Bazar Lucknow.
- 4. An IVF Center for treatment of childlessness will also be established at Cantonment General Hospital, Sadar Bazar, Lucknow Cantt..
- 5. Facility of USG and pathology test will also be provided by them in CGHS Lucknow for treatment of women and pediatrics.
- 6. Benefits of BPL & Ayushman Bharat will also be provided by them as per prevailing guidelines of the Govt.
- 7. All the above medical facilities will be provided by them to the beneficiaries @15% less than CGHS approved rates.

In view of the aforesaid, matter is placed before the Board to consider the following, and any other direction / decision deemed fit:-

- (i) To shift the existing Covid Isolation Center Facility (Level-1) at RA Bazar to Cantonment General Hospital, Sadar Bazar, LucknowCantt.
- (ii) To consider modification / upgradation of exciting facilities and to provide maternity and pediatric ward having OT and USG for Covid and Non-Covid Patients including evening OPD
- (iii) To consider operating of a separate 20 bedded Maternity & Pediatric Covid Isolation Center (Level-1) including 5 bedded NICU/PICU facility to treat Covid positive children / infants on PPP Mode.

Further, existing PPP Partner i.e. Buddheshwar Vimla Hospital may be allowed to run the Maternity & Paediatric Facility / Centre (Level-1) in addition to 40 bedded Covid Isolation Centre (Level-1) presently being run by them on PPP Mode in order to provide continued Medical services as requested vide their letter dated 31.05.2021.

Relevant file and all the concerned documents are put up before the Board for consideration.

# 8. RESOLUTION

The Board considered the matter in detail and resolved to accept the proposal dated 31.05.2021 submitted by Buddheshwar Vimla Hospital.

- (i) The Board considered that there are two part of the proposal:
- (a) One part pertains to opening and operating of Maternity & Paediatric Ward having OT & USG Facility which have already been considered by the Board vide CBR No. 18 dated 16.03.2021.
- (b) Second part pertains to opening and operating of a separate 20 bedded Maternity & Paediatric Covid Isolation Centre (Level-1) included 05 bedded NICU / PICU facility in wake of possible third wave of Covid-19.

As such the Board resolved that this 20 bedded Maternity & Paediatric Covid Isolation Centre (Level-1) shall be part of existing 40 bedded (upgraded to 50 beds) Covid Isolation Centre (Level-1) as approved vide CBR No. 01 dated 19.04.2021 and out of 50 beds, 36 be kept for normal Covid-19 patient in accordance to earlier resolution and 14 beds be converted into Maternity & Paediatric Covid Isolation Centre (Level-1) having additional 06 beds NICU / PICU totaling to 20 beds. Further, the same be opened on the same terms & conditions as approved vide CBR No. 01 dated 19.04.2021 and as agreed upon vide agreement dated 28.04.2021 for a period of 06 months from the date of execution of separate additional agreement for the same.

- (ii) Further, regarding opening of Maternity & Paediatric Ward having OT & USG including evening OPD, the Board resolved to consider the following additional terms and conditions in continuation to earlier CBR No. 18 dated 16.03.2021 and only that part of earlier CBR is amended which differ from this current resolution. The Board resolved to approve the proposal dated 31.05.2021 of Buddheshwar Vimla Hospital, following additional terms & conditions:
- (a) That 10% of total revenue collected shall be shared with Lucknow Cantt Board and 90% of total revenue collected shall be kept by the PPP Partner. Further, the PPP Partner has to deposit the 10% share of Cantt Board by first week of succeeding month.
- (b) That the PPP Partner has to deposit 5% of total revenue collected as infrastructure charges with Cantt Board, and the same has to be deposited by first week of succeeding month along with the 10% revenue share.
- (c) That the PPP Partner has to provide treatment in Maternity & Paediatric Ward having OT & USG service and evening OPD facility as proposed by them vide their proposal dated 31.05.2021 on @ 15% less than prevailing CGHS / Govt. approved rates. Further, if for any

service the prevailing CGHS rates are not available, then State Govt. / AIIMS rates has to be taken as base rates, otherwise CGHS rates will be taken as base reference rate.

- (d) Existing Covid Isolation Center Facility (Level-1), RA Bazar be shifted to Cantonment General Hospital, Sadar Bazar, Lucknow Cantt and existing PPP Partner be allowed to run the centre on the terms and conditions as per agreement executed between Lucknow Cantt Board and Buddheshwar Vimla Hospital. The treatment for newly introduce 20 bedded Maternity & Paediatric Centre & Evening OPD will be provided to the patient on CGHS rates only. Similarly, OT & USG services will also be provided to the patient on CGHS rates only.
- (e) An EMD of Rs. 1,00,000/- in form of DD / Pledged FDR in favour of CEO Lucknow Cantt Board has to be deposited by the PPP Partner as security deposit / performance security which shall be returned after successful completion of agreement period.
- (f) All consequences (Medico Legal / Others) arising out of this facility will be the sole responsibility of the PPP Partner. The Board shall not be a party to any of such cases.
- (g) In case of dispute, between the two parties, the decision of the Principal Director, Defence Estates, Central Command, Lucknow shall be final and binding on both the parties.
- (h) No financial assistance / reimbursement of any kind shall be provided by the Board in case of any loss to PPP Partner.
- (i) The Board will only provide space and existing infrastructure to the PPP Partner for running the centre. The electricity charges and other charges will bear by PPP Partner.
- (j) Buddheshwar Vimla Hospital (PPP Partner) will be responsible for taking necessary required permissions (if any) from the Central/ State Govt. Departments for running the centre.
- (k) All the concerned Act, Rules and Guidelines as issued by the Central / State Govt. in this regard, must be strictly followed by the PPP partner.
- (I) PPP Partner Buddheshwar Vimla Hospital will also ensure proper handling of Medical Waste as per prescribed rules by the State Health Department.
- (m) Cleanliness, Hygiene and Sanitization of the said centre must be ensured at all times by the PPP Partner.
- (n) Fooding and other essential items other than medical service must be provided by the PPP partner at Govt. approved rates.
- (o) 24 Hour availability of Doctors and Paramedical Staff will be ensured by the PPP Partner at Maternity & Pediatric Ward.
- (p) Details of Admission & Discharge of Covid Patients will be made available to the CEO/ Medical Officer of Lucknow Cantonment Board on daily basis and a month report has to be submitted by the PPP Partner by first week of succeeding month. Further, the Board / CEO / Deputy CEO / RMO reserves the right of inspection of the facility & hospital run by PPP Partner along with all the records, as and when required.

- (q) The overall responsibility for running of Maternity & Pediatric Covid Ward having OT & USG for Covid and non Covid patients will be bear by the Buddheshwar Vimla Hospital.
