OFFICE NOTE:-

It is to inform that 04 Nos. old nurses quarter have been constructed in the early 1960's and out lived its use full life, it was found obsolete for further habitation of the staff, therefore, 04 new nurses quarter in lieu of the same, was constructed by the Cantonment Board after obtaining the sanction of the Competent Authority. This construction was completed in 2009 and the nurses residing in old nurse's quarter have been shifted to the newly constructed 04 quarters in the year 2009. Due to shortage of class-III accommodation certain bachelor employees of the Cantonment Board insisted for allotment in the almost abandoned old nurse's quarter. After, the same Board had further made some repair work and gradually the old nurse's quarter has been occupied by 04 Cantt Board staff. The HRA of the employees is also being deducted since 2011.

It is submitted that recently Kitchen slab of one old nurse's quarter have fallen down in Dec' 2020. After further inspection, it has been found that **these 04 quarters are became dangerous for human habitation** Engineering staff recommends for immediate vacation of occupancy in these quarters. Presently one pharmacist and three senior clerks are residing in the said quarters, the notice for vacation of these quarters is to be given immediately to all of them.

It is further, suggested that after demolition of old nurse's quarter the foundation and bricks can be utilized and the pattern of Drawing & design of earlier approved for class-III quarters known as 04 new nurses quarter shall be adopted for special repair, which would be in double storied, two blocks building, connected with common stair case. An approx. estimate for the said special repair is calculated to Rs. 39.00 Lacks. Board may consider further course of action to be taken.
