To consider letter No. nil dated 12.01.2022 received from M/s Indus Towers Ltd regarding renewal of term of license for one year for placing of cell tower and associate equipments on wheels at 2 sites on 'B-4' land under the management of DEO, Lucknow & 08 sites on 'A-1' land in terms of para 8 (b) (ii) & (vii) of Govt of India Ministry of Defence letter No. F-11026/A/2005/D (lands) dated 26.02.2018.

OFFICE NOTE:

The Competent Authority i.e. Principal Director, Defence Estates Central Command vide their letter No. 53905/ Policy/Land/Vol-III/LC-3 dated 14.08.2019 and GOC-in-C vide their letter dated 12.10.2019 had accorded their sanction for the highest Bid for 2 sites on 'B-4' land under the management of DEO, Lucknow & 09 sites on 'A-1' land for two years in terms of policy issued by Govt of India, Ministry of Defence vide letter No. F-11026/A/2005/D(Lands) dated 26.02.2018.For 02 sites which were located on 'B4' land, highest bid was quoted by M/s Indus Towers Ltd. and out of 09 sites which were located on 'A1' land highest bid for 08 sites was quoted by M/s Indus Towers Ltd. and for the remaining 01 site on 'A1' land the highest bid was quoted by M/s Reliance Jio Infratel Pvt. Ltd. Erstwhile M/s Summit Digitel Infrastructure Pvt. Ltd.

Accordingly, MoU between Defence Estates Office Lucknow and M/s Indus Towers Ltd. was executed for 02 sites for 'B4' land and 08 sites for 'A1' land (Si No. 1 to 10 in above table) on 16.01.2020 for a period of 2 years, in terms to sub para (ii) &(viii) of Para 8(b) of Gol, MoD letter No.F.11026/1/2005/D(Lands) dated 26.02.2018 after depositing the requisite security money amounting to Rs. 31,41,564.00 only (10% of bid amount) in the shape of FDR and an amount of Rs. 3,14,15,640.00 as advance annual license fee (Rs 72,63000.00 for B-4 & Rs 2,41,52,640.00 for A-1 Land). Thereafter on completion of one year an amount of Rs. 3,14,15,640.00 was also deposited by the firm as advance annual license fee for the second year. There is no outstanding license fee against any site allotted to M/s Indus Towers Ltd. As per the para 8 (b) (ii) & (vii) of Govt of India Ministry of Defence letter No.F-11026/A/2005/D (lands) dated 26.02.2018 the license was granted initially for a period of 02 years only but it can be renewed at the end of License period by 01 year at a time at the discretion of the licensor on fulfillment of terms and conditions. The total License term shall, However not exceed 05 years.

As regards the site at Base Hospital on Sy No. 495 at Class A1 land, the license was granted to the H1 bidder i.e. M/s Reliance Jio Infratel Pvt Ltd. But as intimated by the Defence Estates Office Lucknow vide their letter No. DEO/LKO/COM/TOWER dated 20.05.2022 the advance license fee amounting Rs. 18,12,000.00 was deposited by the M/s Reliance Jio Infratel Pvt. Ltd. but security money amounting to Rs. 1,81,200.00 (10% of bid amount) was not deposited, and they did not install the Cell Tower on Wheels (COW) also at the site and consequently no agreement was executed with M/s Reliance Jio Infratel Pvt. Ltd.

M/s Indus Towers Ltd vide their letter No. nil dated 12.01.2022 has submitted their willingness for extension of license period for One (01) year for all the 10 sites/ locations allocated to them i.e. 02 sites for 'B4' land and 08 sites for 'A1' land granted to them vide MoU dated 16.01.2020. The Defence Estates office vide their letter No. DEO/Lko/COM/TOWER dated 27.01.2022 has forwarded a proposal to the PDDE CC for the necessary sanction for installing cell towers on wheels (COW) for the 10 sites as requested by M/s Indus Towers Ltd. The PDDE CC vide their letter No. 53905/Policy/Land/Vol.III/LC-3 dated 29.03.2022 has instructed CEO Lucknow to initiate proposal for obtaining sanction of competent authority i.e. PDDE CC for renewal of license for 2 sites on B4 land. It was also instructed to advise Station HQrs Lucknow to initiate proposal for obtaining the sanction of competent authority i.e. GoC-in-C, Central Command for renewal of license for 09 sites of A-1 land placed under management of QMG, through their own channel. Accordingly, the MoU and other details are received to this office from the Defence Estates office vide their letter No. DEO/LKO/COM/TOWER dated 20.05.2022.

Further, in terms of Para 08(b) (vii) of MoD letter dated 26.02.2018 license fee will be revised by 10% on renewal of license. After expiry of maximum 05 years license period, fresh bids will be invited, if so required. The details of the license fee as per MoU dated 16.01.2020 and after 10% enhancement are as under:-
