10. SUPPLY OF GENERIC MEDICINES AND OTHER ALLIED ITEMS IN CANTONMENT GENERAL HOSPITAL LUKNOW

To consider the matter regarding supply of generic medicines and allied items for the cantonment general hospital. Tender was invited for the first time through e - procurement portal and through public notice published in Hindi Daily newspaper Dainik jagran (Hindi) and English Daily the Indian Express (English) on 09.12.2021. On due date i.e., 28.12.2021 (Bid Submission end date) 3 bidders participated and all 3 bidders qualified in the technical bid namely M/s Eastern Medical and Surgical corporation, M/s Edison Drug House and M/s P. Cool and company (Agencies). The financial bids of 3 valid bidders were opened on 06.01.2022. The bidders have quoted rates for majority of the items.

As per the market survey, the lowest rates received are reasonable except item no 245 which are on the higher side. The expenditure in this regard will be booked under Budget head F 16 B.

Board may consider the matter.

11. DISCONTINUATION OF TEH BAZARI IN LUCKNOW CANTT AREA.

To consider the matter regarding discontinuation of collection of Teh Bazari in Lucknow Cantt. Area.

Office Note:

As per Rule No. 67 (g) of Cantonments Act 2006 Teh bazari is regularly collected from the vendors in different area of the Lucknow Cantt. The person from whom, Teh bazari are collected are very poor persons. Details of Collection of Teh Bazari and Expenditure on staff are given below:

It is observed from the recovery that collection on account of Teh Bazari is less during last four years compared to expenditure incurred towards collection of Teh bazari by deploying staff. It is further stated that as per Rule No. 67: "Provided that the fee charged under clause (g) of this section shall not be less than the cost incurred by the Board for or in connection with the specific service to which the fee relates." So as per this section Cantonment board should not collect such fees where expenditure is higher that collection.

It is further stated that the adjoining Lucknow municipal corporation is also not imposing / collecting any Teh Bazari fee from 2013 as Uttar Pradesh, the state government has decided to abolish "Teh bazari". So accordingly Urban Development Secretary directed all urban local bodies of the state have been to abolish Teh bazari.

Further, if collection of Teh Bazari carried out by engaging contractor, then there is very high chance for unauthorized collection by the contractor, mismanagement, manhandling/indiscipline even there is more chances of accidents in roads due to congestion of vendors. 'Teh bazari' is a blot on the modern society. Goondas and Mafias grabs contracts and applies inhuman methods to collect tax.

Since collection of Teh Bazari is not financially viable nor the adjoining municipality are collecting such Teh Bazari in their area. It is proposed that the collection of Teh Bazari may be

discontinued in the Lucknow Cantt. area w.e.f. 01.04.2022. Staff engaged for collection i.e., Peons will be engage/allocate to various schools/sections as per requirements.

Board may consider the matter.

To consider the lowest tender for "AMC of Cantt Board vehicles, 30-60 KVA rating Diesel Generator sets, installed at various pump houses, Cantt Board office, DTE DE CC office and at DE Guest House and Car washer & Tyre Inflator, Lucknow Cantt."

The tenders were invited for the first time through Government e-procurement Portal bearing Tender Ref No. LCB5/E/M/AMC/Vehicle/DG Set/2021 in daily newspapers namely Amar Ujala (Hindi) and The Indian Express (English) on 29.11.2021. In response to the tender notice, only one technical bid was received on 18.11.2021. The tender was cancelled due to insufficient number of technical bid. The tenders were re-invited for the second time through Government e-procurement Portal bearing Tender Ref No. LCB5/E/M/AMC/Vehicle/DG Set/2021 published in daily newspapers namely Rashtriya Sahara (Hindi) and The Indian Express (English) on 21.12.2021. In response to the tender notice, four technical bids were received on 05.01.2022 and after the evaluation of the technical bids; no technical bid was found to be valid and the tender was cancelled due to insufficient number of valid technical bid. The tenders were reinvited for the third time through Government e-procurement Portal bearing Tender Ref No. LCB5/E/M/AMC/Vehicle/DG Set/2022 published in daily newspapers namely Pioneer (Hindi) and The Hindustan Times (English) on 07.01.2022. In response to the tender notice, three technical bids were received on the scheduled date and opened on 14.03.2022 and after the evaluation of the technical bids, only one technical bid was found valid. Accordingly, the financial bid of the valid bidder was opened on 25.03.2022 keeping in view of the fact that the tender is invited for the third time. The details of the same are as under:

Office Note:

The Board has procured 02 Tractors, 02 Tippers, 01 Cattle Catcher and 01 Sprinkler Tanker through GeM in the year 2020 and all these 06 vehicles are additionally included in this BoQ for the tender of the said work since the warranty period of the said vehicles are over.

The item descriptions of 01 Maruti Omni Ambulance Van has been removed from the BoQ of the tender for the said work since the same has completed its useful life and will be replaced in near future by new one.

Last year rates approved by Board vide its CBR No. 19 dated 28.11.2020 were 13.96 lacs approx, whereas this year lowest rates are 14.65 lacs (which includes addition of 06 new vehicles and removal of 01 vehicle). The lowest tender rates of Rs 14,65,104/- for the work of "AMC of Cantt Board vehicles, 30-60 KVA rating Diesel Generator sets, installed at various pump houses, Cantt Board office, DTE DE CC office and at DE Guest House and Car washer & Tyre Inflator, Lucknow Cantt" are quoted by M/s Oudh Tractor Engineering Works for the subject work are reasonable since the lowest rates quoted are at par same as compared to the lowest rates approved by the Board vide its CBR No. 19 dated 28.11.2020 and as per prevailing market rates. The contract value of the work is Rs 14,65,104/- only.

To consider the matter regarding partial modification in CBR under reference for revised sanction of 1^{st} Selection Grade for completion of 14 years satisfactory service as per conditions laid down in UP Govt. Order no. वे0आ0–2–560 / दस–45(एम)–99 dated 02.12.2000 and also grant of revised sanction of 2^{nd} ACP and 3^{rd} ACP to Shri Vishnu Kumar Singh (RtdJ.E.Civil) as per conditions i.e. example no. 2(i) laid down in UP Govt. Order no. वे0आ0–2–773 / दस–62(एम) / 2008 dated 5^{th} Nov'2014 on completion of 16 years & 26 years satisfactory` service. Matter of grant of 1^{st} Selection Grade (Time Scale) for next higher Pay Scale Rs. 8000-275-13500 to Shri V.K. Singh were put-up before the board & Board vide CBR no. 11 dated 30.08.2001 resolved to grant the same. Then proposal of Shri V.K.Singh was sent to competent authority PD DE CC for grant of 1^{st} Selection Grade as per resolution by the Board. After cancellation of Sanction letter from Dte. DE CC, the revised Pay Scale fixation proforma was send to Local Audit Authority (LAO) for audit vide this office letter no. LCB/2/Acctt/2021 dated 14.12.2021. LAO raised a following queries.

"As per para 06 of PDDE Lucknow No.PC-34238/LKO/VKS/21/C-1192 dated 09.12.2021, Sanction letter No.PC/34238/AGRA/LC-6 DATED 23.06.2005 has been cancelled and no further revised order for grant of any Scale has been issued. As such, please arrange to forward revised order for grant of higher Pay Scale, if any issued by PDDE and copy of office order published on the basis of such order. Subsequent orders for the promotional scale/MACP granted if any granted may also be revised by competent authority"
