

Pharmacist: List of Eligible Candidates for Written Exam

Note:

1. Please note that list of eligible candidates for the written exam, admit card and selection of candidate is provisional. Appointment letter to the selected candidate will be issued only after checking of original and complete documents as per eligibility criteria in the vacancy advertised. In case the selected candidate does not fulfil the eligibility criteria, then in that case, his or her selection will be rejected and candidate will have no claim based on issuance of admit card and declaration of result.
2. Admission certificate be downloaded from official website i.e. <https://lucknow.cantt.gov.in> , <https://iforms.mponline.gov.in> and MPOne Portal (<https://www.mponline.gov.in>) from 20.01.2023. For the eligible candidates from Employment Exchange, admission certificate will be sent through E-Mail/ WhatsApp/ Speed Post to their mentioned address by Employment Exchange.
3. At the time of form filling on MPOne Portal, due to some technical issues number of Candidates unable to upload the document or incorrectly uploaded documents or incompletely uploaded the documents, due to which number of candidates requested correction in application form or uploading of documents for which correction link have been made active but again due to technical error number of candidates not able to make corrections. It is also stated that many candidates uploaded unreadable documents or incomplete documents. Accordingly Competent Authority has decided to allow all the candidates who have made the successful payment of application form fee, they will be allowed for written exam as eligible candidates along with instructions mentioned in "Remark/ Documents Required" column.
4. Documents mentioned or Remarks mentioned in "Remark/ Documents Required" column are to be produced by the Selected Candidate at the time of verification of documents. In case the selected candidate does not produce the document mentioned in the "Remark/ Documents Required" column, then in that case, his or her selection will be rejected and candidate will have no claim based on issuance of admit card and declaration of result.
5. For Person with Disability Candidate, it is stated that their form fee will be refunded before the 12th May 2023 in their bank account.
