

Minutes of the Board meeting of Lucknow Cantonment Board to be held on 26.05.2023 at 1100 hours.

**1. COMPREHENSIVE SANITATION MAINTENANCE WORK OF SADAR BAZAR, RBI BAZAR, HATA RAM DAS, BADI LAL KURTI, MALL AVENUE, 21 PGLS IN CIVIL/BUNGALOW AREAS & 02 WASH ROOMS AT KASTURBA ROAD WALKING PLAZA, LUCKNOW CANTT FOR THE PERIOD OF TWO YEARS**

To consider the lowest bid for Comprehensive Sanitation Maintenance work of Sadar Bazar, RBI Bazar, Hata Ram Das, Badi Lal Kurti, Mall Avenue, 21 PGLs in Civil/ Bungalow areas & 02 Wash Rooms at Kasturba Road walking plaza, Lucknow Cantt. for a period of two years.

**Office Note:**

A custom bid (Services) No. GEM/2022/B/2914188 for the work of Comprehensive Sanitation Maintenance work of Sadar Bazar, RBI Bazar, Hata Ram Das, Badi Lal Kurti, Mall Avenue, 21 PGLs in Civil/ Bungalow areas & 02 Wash Rooms at Kasturba Road walking plaza, Lucknow Cantt on **QCBS Method (Quality cum Cost Based Selection)** for a period of two years is published for the first time on GEM portal on 28.12.2022. In response to the same, Seven Bids were received on the scheduled date of opening of bid i.e. 11.01.2023 and after technical evaluation of the same it is found that only two bidders qualifies the technical qualification criteria of the Bid. The details of the bids received are as under:-

The disqualified bidders as mentioned above have been intimated about the specific reasons for their disqualification on 05.04.2023 and time duration of 48 hours was given to them for submitting the shortfall documents/clarification as per GeM rules & regulations for their further consideration in their technical evaluation. It is further submitted that after the completion of 48 hours' time slot given to the participating bidders as mentioned above, four bidders have submitted their shortfall document/ clarifications for further consideration and after technical evaluation, three more bids were found to be valid. Hence **total five firms get qualified** in the bidding process. Accordingly, the financial bids of the eligible 05 bidders were opened on 20.04.2023 the details of the same are as under: -

It is stated that in QCBS method, Rank (score) is calculated from highest to lowest based on marks obtained in technical evaluation and quoted rates. Normally H1 rank bidder is considered suitable for contract. It is seen that the price quoted by M/s Agarwal & Co. for the complete contract (**H1 ranked Bidder**) is **Rs. 27,30,000/- which is abnormally low** as compared to the estimated cost of the work i.e. Rs. 7,70,00,000/-. Lucknow Cantonment Board vide office letter dated 03.05.2023 sought clarification regarding the same from M/s Agarwal & Co. The firm vide its letter dated 05.05.2023 clarified that the rates amounting to Rs. 27,30,000/- as quoted by him is for one month and he further requested to consider Rs. 6,55,20,000/- (Rs. 27,30,000/- x 24) for complete two years. As it is open tender and rates quoted once cannot get changed. So recommended for rejection of H1 **ranked bidder** and revised Comparison of Scores is given below for consideration.

M/s Q Security Services is H1 **ranked** bidder and has quoted rates of Rs. 5,60,10,240/- for the job work of Comprehensive Sanitation Maintenance work of Sadar Bazar, RBI Bazar, Hata Ram Das, Badi Lal Kurti, Mall Avenue, 21 PGLs in Civil/ Bungalow areas & 02 Wash Rooms at Kasturba Road walking plaza, Lucknow Cantt for a period of two years. The rates are reasonable and it is **28.63%** less than the previous rates (Rs 78480000) and it is **27.26%** less than the estimated rates (Rs 77000000).

In response to the same, two bids were received on the scheduled date of opening of bid i.e. 11.01.2023 and after technical evaluation of the same it is found that no bidder qualifies the technical qualification criteria of the Bid. The disqualified bidders as mentioned above have been intimated about the specific reasons for their disqualification on 05.04.2023 and time duration of 48 hours was given to them for submitting the shortfall documents/ clarifications as per GeM rules & regulations for their further consideration in the technical evaluation. It is further submitted that after the completion of 48 hours' time slot given to the participating bidders as mentioned above, one bidder has submitted

its shortfall document/ clarifications for further consideration and after its technical evaluation, it is found to be valid. Hence **only one bidder** M/s Mithilesh Sahu & Sons, 96, Ghusawal Kala Barona Lucknow gets **qualified** in the bidding process. The financial bid of the eligible bidder was opened on 24.04.2023 the details of the same are as under: -

It is stated that in QCBS method, Rank (score) is calculated from highest to lowest based on marks obtained in technical evaluation and quoted rates. Normally H1 rank bidder is considered suitable for contract. The rates quoted by (H1 ranked bidder and only qualified bidder) M/s Mithilesh Sahu & Sons are reasonable since it is **5.04%** higher than the previous rates (Rs 35,70,000).

In response to the same, six bids were received on the scheduled date of opening of bid i.e. 23.12.2023 and after technical evaluation of the same it is found that three bidder qualifies the technical qualification criteria of the Bid. The disqualified bidders as mentioned above have been intimated about the specific reasons for their disqualification on 24.04.2023 and time duration of 48 hours was given to them for submitting the shortfall documents/ clarifications as per GeM rules & regulations for their further consideration in the technical evaluation. It is further submitted that after the completion of 48 hours time slot given to the participating bidders as mentioned above, one bidder has submitted its shortfall document/ clarifications for further consideration and after its technical evaluation, the same is found to be valid. Hence, four firms get qualified in the bidding process. The financial bid of the **04 eligible bidders** were opened on 01.05.2023 and the details of the same are as under: -

It is seen that the price quoted by M/s Man Singh Yadav for the complete contract (L1 Bidder) is Rs. 176/- which is abnormally low as compared to the estimated cost of the work i.e. Rs. 11,66,400/-. Lucknow Cantonment Board sought clarification regarding the same from M/s Man Singh Yadav on GeM portal on 03.05.2023. The firm submitted its reply on 05.05.2023 clarified that the rates amounting to Rs. 176/- as quoted by him is only the menu cost i.e. cost of meal per person per day and he further submitted that the total cost of his bid is Rs. 11,40,480/- (Rs.176/- x 9 person x 30 days x 24) for complete two years. As it is open tender and rates quoted once cannot get changed. **So recommended for rejection of L1 bidder and consideration of L2 bidder.** M/s Bajpai Tent House & Caterers is L2 bidder and has quoted rates of Rs. 8,86,950/- for a period of two years. The rates are reasonable and it is 23.96 % less than the estimated rates (Rs. 1166400).

### 3. RESOLUTION

Considered and approved the rates of Rs. 8,86,950/- quoted by M/s Bajpai Tent House & Caterers. Necessary agreement be executed with the firm.

Lucknow Cantonment Board vide letter referred above had requested to ICICI Foundation for providing one USG Machine, one RTPCR Testing Machine and one Immunoassay Testing Machine under CSR Funds. ICICI Foundation has considered the request of Lucknow Cantonment Board and approved to provide one USG Machine, one RTPCR Testing Machine and one Immunoassay Testing Machine under CSR Funds for Cantonment General Hospital.

In the month of February 2023, ICICI Foundation has installed RTPCR Testing Machine and Immunoassay Testing Machine at Cantonment General Hospital. Further, USG Machine will also be installed after obtaining the PCPNDT Certificate from the Competent Authority.

There is a requirement of USG Machine Printer for the USG Machine. In this regard, M/s Color Cloud Healthcare India Pvt. Ltd. approached Lucknow Cantonment Board for supply and installation of CISCOM Color Printer for USG Machine. M/s Color Cloud Healthcare India Pvt. Ltd. vide their proposal letter dated 23.02.2023 proposed that they will supply & install CISCOM Printer with CISCOM Software free of cost for USG Machine at Cantt General Hospital. Only Rs. 1,50,000/- (Refundable after completion of Agreement) security deposit and Rs. 30 + 18% GST per print charges will be borne by Lucknow Cantonment Board. Approx 2500/- expenditure per month considering 50 Ultrasound. Further, M/s Color Cloud Healthcare India Pvt. Ltd. will provide installation, consumables-machine parts training, demo & paper free of cost.

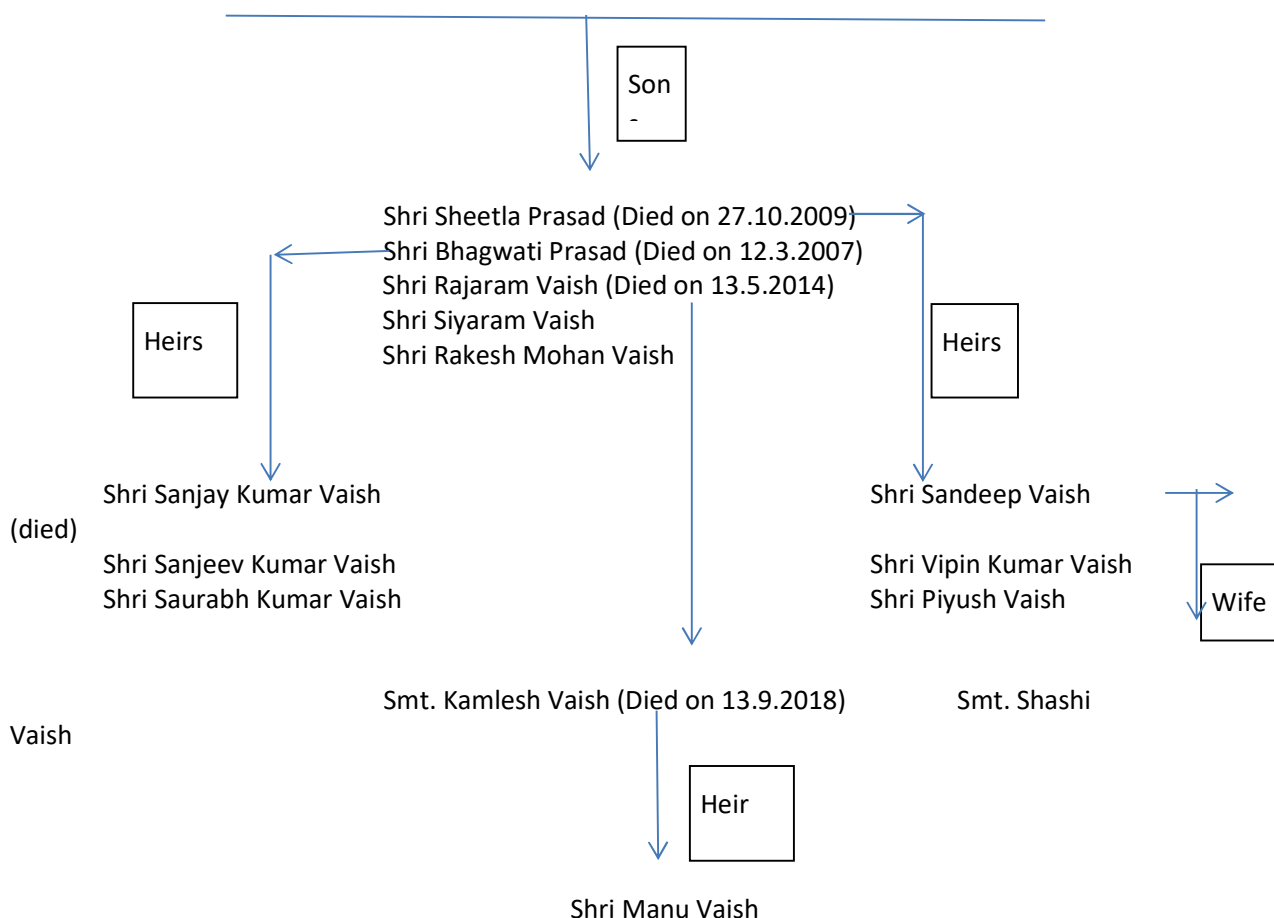

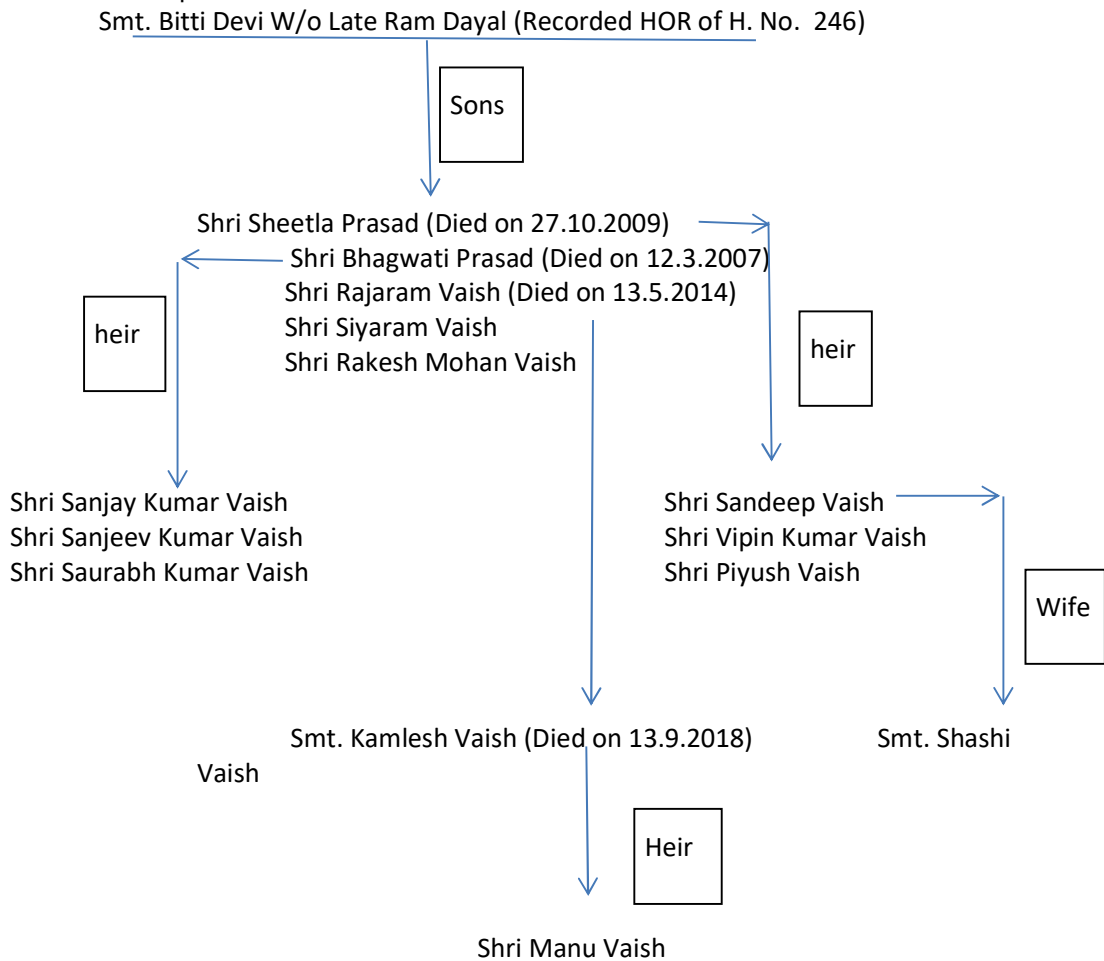

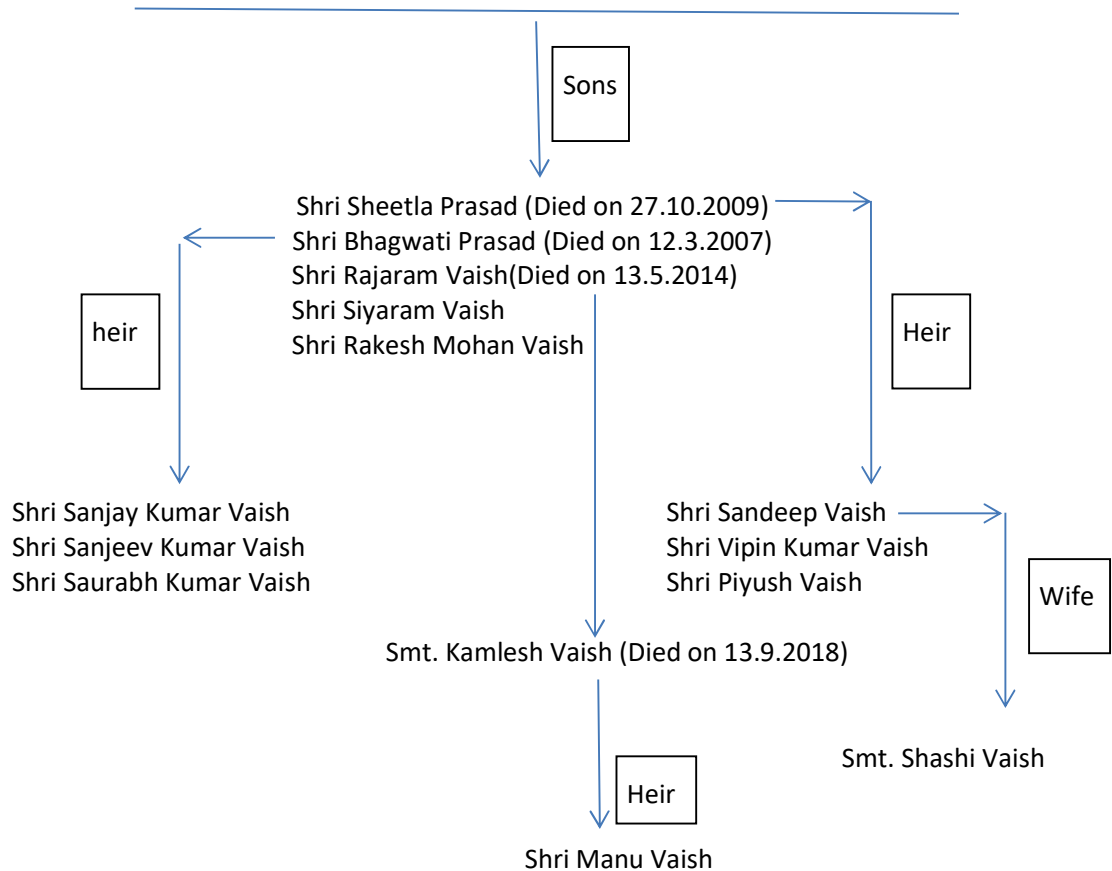

DG DE vide letter No.DE/965/NRSC/CoW/NIDEM dated 12.08.2022 & Dte DE CC letter No.52727/Cantt/Sy.Unit/IX dated 09.09.2022 has issued the instruction about Threat Matrix as a measure to protect defence lands and accessed the feasibility for protection of defence lands (B- 4 & C) in Lucknow Cantonment in association with the office of the Defence Estates Officer Lucknow Circle Lucknow. After physical site verification of the Perimeter of B-4 & C lands under the management of Cantonment Board Lucknow and the detail of the Perimeter of B-4 land under the management of DEO has been ascertained in which the length of the Perimeter for construction of boundary wall has been calculated with the help of Google earth. The unit rates provided by **AGE B&R –I (West) MES Lucknow dated 05.01.2023**, the estimate has been worked out by multiplying unit rates by the length of boundary walls/fencings and erection of boundary pillar.

Accordingly, Cantonment Board Lucknow prepared the threat matrix for B-4 land, under the management of Cantonment Board Lucknow. As per the direction of the Higher Authority, classified the Defence land pockets into 03 categories i.e., Red Zone, Blue Zone and Green Zone. Sy No. 86 falls under Blue Zone and has an area of 1.25 Acre.

Fencing is recommended secure the Defence land from the growing threat of encroachments. It is difficult to keep proper watch and ward off the same in absence of boundary walls. It will enable Cantonment Board Lucknow to keep regular vigil thereon and to look after the said defence land effectively.


