The estimates are prepared as per the requirement of site. The above estimates are prepared based on the contract called as per MES SSR 2020. Which has been approved by the Board vide dated 06.12.2022 the above estimates have been prepared by technical section of this office and vetted by AE of this office.

1. RESOLUTION

2. REGULARIZATION OF THE IRRECOVERABLE LOSSES RS. 2,81,004/-.

Reference your Dte letter No. 96342/MFAI/CDA Lko/Cantt dated 01st June 2023.

1. It is submitted that Shri R.C Singh, Ex Sr. Clerk was removed from service of the Board w.e.f 24.02.2004 after enquiry on the charge of Misappropriation of money by making fraudulent manipulation in Pension Accounts of Cantt Board. The Board also resolved to recover the entire misappropriated amount of Rs. 2,81,004/- but Shri R.C Singh died in 2011 and has not left behind any movable or immovable assets. Since it is not possible to recover Rs. 2,81,004/-, it is recommended for waiving of loss under Rule 203 (4) (C), of the Cantonment Board Account Rules, 2020. Competent authority for regularization of the irrecoverable losses is GOC_in_C as per Rule 203 (4) (C), of the Cantonment Board Account Rules, 2020. LAO also recommended for regularization of the irrecoverable losses vide letter dated 20.12.2022 to PCDA.

- 2. It is further submitted that the "Misappropriation of money by making fraudulent manipulation in Pension Accounts of Cantt Board, Lucknow" figures in the internal Audit Report & MFAI report of PCDA (CC) Lucknow since 12/1996 and PCDA (CC) Lucknow has been pressing very hard for settlement of aforesaid objection since then.
- 6. As PCDA stated to regularize irrecoverable losses, proposal needs to be submitted to GOC_in_C to regularize/write-off/waiving of the irrecoverable losses. After approval of GOC_in_C as per Rule 203 (4) (C), of the Cantonment Board Account Rules, 2020, case will be submitted to audit to settle MFAI case.

2. RESOLUTION

Matter has been considered in details and approved for regularization of the irrecoverable losses Rs. 2,81,004/- and necessary proposal be sent to higher authority for regularization.

The Board has procured one **Escort Backhoe Loader Registration No. UP32 PN6475** through GeM in the year 2021, the said vehicle is included additionally in this BoQ for the tender of the said work since the warranty period of the said vehicle is over.
